Explanation of Responses:

1. The options are subject to a service-based vesting requirement, which shall be satisfied over a four-year period. 25% of the options shall vest on August 30, 2022 and 1/48th of the options vest monthly thereafter, subject to the Reporting Person's continuous service with the issuer. The options are exercisable into shares of Class B Common Stock, which are convertible on a one-to-one basis into shares of Class A Common Stock at the option of the holder. The options may also be early exercised, subject to the issuer's right of repurchase.
